### Peter Harte

**Chairman IWEA**

Peter is currently the Chief Technology Officer and Director at Element Power Ireland, based in Cork. Element Power Ireland has successfully developed a national portfolio of c350MW under Development, c120MW of projects under Construction, and c100MW in Operation. Element Power Ireland is also developing the Greenlink project, which plans to develop a 700MW interconnector between Wales and Great Island. Peter is Chairman of the Irish Wind Energy Association (IWEA) and previously chaired the Grid and Markets Committees. He holds a B.Eng in Mechanical Engineering at the University of Limerick.
